



Thank you for helping circulate my petition for the Illinois State Senate! I love being able to represent you and our shared interests in Springfield. Below are the directions for how to legally collect signatures to ensure I get onto the ballot. Directions for Circulating Senator Dan McConchie's Petition

1. To circulate Senator McConchie's petition, you only need to declare yourself to be a Republican during the 2022 election cycle. You need not have voted in a Republican Primary previously.
2. You may circulate petitions for any other Republican, but you cannot circulate petitions for any other political party. You may sign any Republican's petition this cycle, but **DO NOT** sign a petition from any other party. If you do, the signatures you collect for a Republican could be invalidated.
3. You must be at least 18 years of age to circulate. However, if you are 17 years old and will be 18 by the date of the General Election, and are a U.S. citizen, you may also circulate this petition.
4. You must personally witness all signatures made on this petition. Do **NOT** leave the petition form unattended where someone could sign without your observing it.
5. Ensure the voter signing actually lives in the 26th Senate District. A map is attached to help guide you. You may sign your own petition if you live in the district.
6. Petitions with fewer than 10 names do count. If you are not able to fill an entire petition, send in the partially completed petition. Each name counts!
7. If you learn a signature is not valid, do not worry. Bad signatures do not knock out other good signatures or invalidate a petition. **HOWEVER**, known bad signatures should be brought to the attention of the campaign, so that they can be officially deleted. A circulator who recklessly and routinely disregards the signature gathering rules may have an entire sheet stricken even though some signatures are valid.
8. You must sign as the circulator of the petition before a Notary Public licensed in Illinois and the Notary Public must affix his/her seal or stamp. Most banks and libraries will notarize free of charge. Contact Senator McConchie's campaign if a notary is needed.
9. **Very important: DO NOT number the petition page.** They will be numbered later.

Directions for Signing 

<p style="text-align: center;">Directions for <u>Signing</u> Senator Dan McConchie's Petition</p>

1. You must be a registered voter in the 26th Legislative District. You need not have voted in a previous Republican Primary and may even have voted in a Democrat Primary or not even have voted in a primary at all.
2. You must sign your name as you did when you registered to vote. For example, William E. Jones, not Bill Jones.
3. DO NOT use ditto marks for any part of an address or county.
4. You must use the address where you are registered to vote. Post Office boxes are not acceptable.
5. You MAY NOT sign petitions for candidates of more than one political party in the same election.
6. You cannot sign another member of your family's name on a petition.
